The 2024 District Lodge Meeting and Convention will be held at the Tuscany Suites & Casino at 255 East Flamingo Road, Las Vegas, NV 89169.

The dates of the convention are Friday, June 21 through Sunday, June 23, 2024. **Friday** is an optional Cultural Day focusing on Vikings. Although Friday is optional, we think most delegates and local folks will attend. Friday evening is the President's reception and Viking dinner. Leadership workshops are **Saturday** morning with the memorial service and opening ceremonies in the afternoon. Also, Saturday evening is an open night with social/activity options and time for shopping. **Sunday** is business sessions and the banquet. Guests are welcome to attend convention activities, including the vendor shopping and the Folk-Art Exhibition. Vendors shall pay District Six Sons of Norway 10% of receipts for sales made during the event or commissioned at the event. All commission payments shall be made at the event site at the close of Sunday night or at other times, if not staying through Sunday night.
